**1. IT IS THE LAW: Any rider under 18 years old MUST WEAR A HELMET! Helmets are provided and are no extra charge, if you DECLINE the use of a helmet and receive a ticket Bee2gether Bikes is not responsible to pay any fees owing for the ticket.**

- I accept for use as is the equipment (bicycle, helmet, lock) listed on this form and I accept full responsibility for the care of the equipment while it is in my possession.
- I will be responsible for the replacement, at full retail value, of any equipment rented under this form which is not returned to the shop, and I acknowledge my obligation to return this equipment by the agreed date and time in clean, unharmed condition, to avoid any additional costs.
- I agree to hold harmless and indemnify Bee-2-Gether Tandem Bike Rentals & Sales and its officers, agents, employees and representatives, etc., for any loss or damage, including damage related in any way to the use of this equipment except reasonable wear and tear of the equipment itself.
- I understand there are inherent and other risks involved in the sport for which this equipment is to be used, and that injuries are common and ordinary occurrence of the sport and I freely assume those risks.
- I made no misrepresentation to Bee-2-Gether Tandem Bike Rentals & Sales with regard to any information which they have requested of me to the rental and / or my use of the equipment.
- Full instruction on the use of this equipment have been made clear to me, and I understand the use and function of my equipment.

### 8. RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the rental of the Equipment, I hereby agree as follows:

- TO RELEASE Bee-2-Gether Tandem Bike Rentals & Sales and the manufacturer and distributor of the Rental Equipment and their directors, officers, employees, agents and representatives (all of whom are hereinafter collectively referred to as "the Releases") FROM ANY AND ALL LIABILITY AND TO WAIVE ALL CLAIMS AGAINST THE RELEASEES for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer resulting from the use of the Equipment DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF WARRANTY ON THE PART OF THE RELEASEES in respect to the design, manufacture, selection, installation, maintenance or adjustment of the Equipment, or in respect of the provision of or the failure to provide any warnings, directions, instructions or guidelines as to the use of the Equipment; and
- TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any loss, damage, injury or expense to any third party, resulting from the use of the Equipment.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
